# **RUBY CASTLE WET/DRY COMBO RULES**

#### \*NOTE: WATER MUST BE TURNED OFF BEFORE DEFLATING\*

- 1. USE POTABLE WATER ONLY, FROM A WELL-MAINTAINED WATER SOURCE. IF WATER BECOMES DIRTY, DRAIN AND REFILL.
- 2. ATTENDANT (AT LEAST 16 YEARS OF AGE) MUST BE PRESENT AT ALL TIMES.
- 3. THE ATTENDANT(S) MUST ENFORCE ALL RULES AND MUST REMOVE ANY RIDER WHO DOES NOT FOLLOW THE RULES.

### WARNING! DO NOT REMOVE G. F. C. I.

- 4. ATTENDANTS AND RIDERS MUST NOT BE UNDER THE INFLUENCE OF ANY MIND-ALTERING SUBSTANCE (DRUGS, ALCOHOL, MEDICATIONS, ETC.) DURING OPERATION.
- ABSOLUTELY NO ROUGH PLAY, TUMBLING, FLIPPING OR DIVING ALLOWED.
- 6. REMOVE SHOES, EYEGLASSES, AND ALL SHARP OBJECTS, INCLUDING JEWELRY.
- 7. NO FOOD, DRINK, OR GUM AND ABSOLUTELY NO SILLY STRING.(CLEANING CHARGES WILL BE ADDED)
- 8. NO WET FACE PAINT.
- 9. DO NOT OPERATE UNIT IN RAIN, LIGHTNING, DARKNESS, OR IN WINDS EXCEEDING 20 MPH.
- 10. IF THE UNIT BEGINS TO LOSE AIR, UNLOAD RIDERS. CHECK YOUR POWER SOURCE FOR A POSSIBLE POWER PROBLEM.
- 11. ONLY ONE RIDER AT A TIME TO GO DOWN THE SLIDE SEATED ON THIER BOTTOM AND FEET FIRST.

  NO ADDITIONAL RIDERS CAN GO DOWN UNTIL THE PREVIOUS RIDER HAS EXITED THE SLIDE SAFELY.
- 12. NO MORE THAN TWO PEOPLE AT THE TOP OF THE SLIDE AT A TIME.
- 13. RIDERS SHOULD NEVER ATTEMPT TO CLIMB UP THE SLIDE IN THE WRONG DIRECTION.
- 14. DO NOT ALLOW CHILDREN OUTSIDE THE UNIT TO KICK, HIT, JUMP OR CLIMB ON THE SLIDE.
- 15. MAXIMUM LOAD: 6 MAXIMUM WEIGHT: 100 LB PER PERSON

  MINIMUM HEIGHT: 36" MAXIMUM HEIGHT: N/A

  MAXIMUM AGE: N/A
