## SPIDERMAN 3 IN 1 COMBO RULES

1. ATTENDANT (AT LEAST 16 YEARS OF AGE) **MUST** BE PRESENT AT ALL TIMES.
2. THE ATTENDANT(S) MUST ENFORCE ALL RULES AND MUST REMOVE ANY RIDER WHO DOES NOT FOLLOW THE RULES.
3. ATTENDANTS AND RIDERS MUST NOT BE UNDER THE INFLUENCE OF ANY MIND-ALTERING SUBSTANCE (DRUGS, ALCOHOL, MEDICATIONS, ETC.) DURING OPERATION.
4. ABSOLUTELY NO ROUGH PLAY, TUMBLING, FLIPPING OR DIVING ALLOWED.
5. REMOVE SHOES, EYEGLASSES, AND ALL SHARP OBJECTS, INCLUDING JEWELRY.
6. NO FOOD, DRINK, OR GUM AND **ABSOLUTELY** NO SILLY STRING.(CLEANING CHARGES WILL BE ADDED)
7. NO WET FACE PAINT.
8. DO NOT OPERATE UNIT IN RAIN, LIGHTNING, DARKNESS, OR IN WINDS EXCEEDING 20 MPH.
9. IF THE UNIT BEGINS TO LOSE AIR, UNLOAD RIDERS. CHECK YOUR POWER SOURCE FOR A POSSIBLE POWER PROBLEM.
10. ONLY ONE RIDER AT A TIME - TO GO DOWN THE SLIDE SEATED ON THIER BOTTOM AND FEET FIRST. **NO** ADDITIONAL RIDERS CAN GO DOWN UNTIL THE PREVIOUS RIDER HAS EXITED THE SLIDE SAFELY.
11. NO MORE THAN TWO PEOPLE AT THE TOP OF THE SLIDE AT A TIME.
12. RIDERS SHOULD NEVER ATTEMPT TO CLIMB UP THE SLIDE IN THE WRONG DIRECTION.
13. DO NOT ALLOW CHILDREN OUTSIDE THE UNIT TO KICK, HIT, JUMP OR CLIMB ON THE SLIDE. RIDERS SHOULD NEVER ATTEMPT TO CLIMB UP THE SLIDE GOING IN **THE WRONG** DIRECTION.
14. MAXIMUM LOAD: 6 MAXIMUM WEIGHT: 100 LB PER PERSON  
 MINIMUM HEIGHT: 36" MAXIMUM HEIGHT: N/A  
 MAXIMUM AGE: 12 MINIMUM AGE: N/A
