HOSE HOCKEY

IT'S NOT JUST AIR HOCKEY, IT'S HOSE HOCKEY! TWICE AS MUCH FUN AND TWICE AS MUCH AIR! SEPARATE INTO TEAMS AND PICK YOUR SIDE AS TEAMS BATTLE FOR "ICE" SUPREMACY. USE THE AIR HOSES TO SHOOT THE PLASTIC BALL AROUND THE "RINK" AND INTO THE OTHER TEAMS NET. EACH TEAM USES THEIR COLOR-CODED AIR HOSES TO BLOW A ROLLING PUCK INTO THEIR OPPONENTS' GOALS. GREAT FOR BOTH KIDS AND ADULTS. CAN HAVE UP TO 6 PLAYERS AT A TIME.

RULES

1. BE SURE THAT THERE ARE NO CHILDREN OR ADULTS ON THE UNIT ITSELF. IF LEFT UNATTENDED, CHILDREN HAVE THE TENDENCY TO WANT TO PLAY ON TOP OF THE UNIT. WE ADVISE THAT THIS UNIT NOT BE LEFT UNATTENDED FOR SAFETY REASONS.
2. ADULT SUPERVISION IS SUGGESTED AT ALL TIMES.
3. THE ATTENDANT(S) MUST ENFORCE ALL RULES AND REMOVE ANY PARTICIPANT WHO DOES NOT FOLLOW THE RULES.
4. ATTENDANTS AND PARTICIPANTS MUST NOT BE UNDER THE INFLUENCE OF ANY MIND-ALTERING SUBSTANCE (DRUGS, ALCOHOL, MEDICATIONS, ETC.) DURING OPERATION.
5. ABSOLUTELY NO CLIMBING ON THE UNIT.
6. NO FOOD, DRINK, OR GUM AND ABSOLUTELY NO SILLY STRING. (CLEANING CHARGES WILL BE ADDED)
7. DO NOT OPERATE UNIT IN RAIN, LIGHTNING, DARKNESS, OR IN WINDS EXCEEDING 20 MPH.
8. IF THE UNIT BEGINS TO LOSE AIR CHECK YOUR POWER SOURCE FOR A POSSIBLE POWER PROBLEM.

SET UP

1. REMOVE UNIT FROM BAG AND UNROLL ONTO A SMOOTH, LEVEL SURFACE.
2. TIGHTLY STRAP THE UNIT'S BLOWER TUBE ONTO THE INFLATABLE. PLUG THE BLOWER INTO YOUR ELECTRIC OUTLET. THERE IS A TOGGLE SWITCH LOCATED ON THE FRONT OF THE BLOWER. TURN IT ON AND THE UNIT WILL BEGIN INFLATING. *NOTE: THE BLOWER SITS UNDERNEATH THE INFLATABLE. MAKE SURE THE BLOWER TUBE IS NOT TWISTED OR PINCHED.
3. THERE ARE TWO VENTS THAT YOU WILL NEED TO CLOSE TO ALLOW THE UNIT TO FULLY INFLATE. BOTH ARE LOCATED ON THE OUTSIDE OF THE UNIT, ONE ON EACH END.
4. AFTER THE UNIT IS INFLATED, USE THE TIE-DOWN STRAPS TO SECURE IT IN PLACE. (STAKES OR SANDBAGS, DEPENDING ON WHERE THE UNIT IS SET UP.

I HAVE READ AND UNDERSTAND THESE RULES. I WILL SEE THAT THEY ARE ENFORCED.
