MECHANICAL FOOTBALL

1. ALL RIDERS, REGARDLESS OF AGE, MUST HAVE A COMPLETED WAIVER TO PARTICIPATE.
2. TRAINED OPERATOR **MUST** BE PRESENT AT ALL TIMES. IF OPERATOR IS NOT PRESENT, THE RIDE IS CLOSED.
3. THE OPERATOR MUST ENFORCE ALL RULES AND REMOVE ANY RIDER WHO DOES NOT FOLLOW THE RULES. DO NOT ATTEMPT TO GET ON TO THE FOOTBALL UNTIL INSTRUCTED TO DO SO BY THE OPERATOR.
4. OPERATOR AND RIDERS MUST NOT BE UNDER THE INFLUENCE OF ANY MIND-ALTERING SUBSTANCE (DRUGS, ALCOHOL, MEDICATIONS, ETC.) DURING OPERATION.
5. RIDERS **MUST NOT** BE PREGNANT, HAVE EPILEPSY, MUSCULAR COMPLAINTS, NECK OR SPINAL (BACK) PROBLEMS, OR ANY OTHER PHYSICAL AILMENT THAT WOULD INHIBIT THE RIDER TO RIDE SAFELY.
6. RIDERS MUST BE AT LEAST 48" TALL, UNDER 250 LBS. AND ABLE TO MOUNT THE FOOTBALL WITHOUT ASSISTANCE.
7. WHEN READY, THE RIDER WILL HAVE ONE HAND ON THE ROPE AND ONE HAND IN THE AIR
8. RIDER MAY STOP THE RIDE AT **ANY** TIME.
9. ABSOLUTELY NO ROUGH PLAY, TUMBLING, FLIPPING OR DIVING ALLOWED.
10. REMOVE SHOES, EYEGLASSES AND ALL SHARP OBJECTS, INCLUDING JEWELRY.
11. NO FOOD, DRINK, OR GUM AND **ABSOLUTELY** NO SILLY STRING. (CLEANING CHARGES WILL BE ADDED)
12. NO WET FACE PAINT.
13. DO NOT OPERATE UNIT IN RAIN, LIGHTNING, DARKNESS, OR IN WINDS EXCEEDING 20 MPH. UNIT **MUST** BE SET UP UNDER COVER.
14. IF THE UNIT BEGINS TO LOSE AIR, UNLOAD RIDERS. CHECK YOUR POWER SOURCE FOR A POSSIBLE POWER PROBLEM.
15. THERE ARE INHERENT RISKS IN THE PARTICIPATION IN OR ON ANY AMUSEMENT RIDE, DEVICE OR ATTRACTION. PATRONS ACCEPT THE RISKS INHERENT IN SUCH ACTIVITY. PATRONS HAVE A DUTY TO EXERCISE GOOD JUDGEMENT AND ACT IN A RESPONSIBLE MANNER WHILE USING THE EQUIPMENT AND TO OBEY ALL ORAL AND WRITTEN WARNINGS.
