### 16' TROPICAL RUSH SLIDE RULES

**\*NOTE: WATER MUST BE TURNED OFF BEFORE DEFLATING\***

1. USE POTABLE WATER ONLY, FROM A WELL-MAINTAINED WATER SOURCE. IF WATER BECOMES DIRTY, DRAIN AND REFILL.
2. ATTENDANT (AT LEAST 16 YEARS OF AGE) MUST BE PRESENT AT ALL TIMES.
3. THE ATTENDANT(S) MUST ENFORCE ALL RULES AND MUST REMOVE ANY RIDER WHO DOES NOT FOLLOW THE RULES.

#### **WARNING! DO NOT REMOVE G. F. C. I.**

4. ATTENDANTS AND RIDERS MUST NOT BE UNDER THE INFLUENCE OF ANY MIND-ALTERING SUBSTANCE (DRUGS, ALCOHOL, MEDICATIONS, ETC.) DURING OPERATION.
5. ABSOLUTELY NO ROUGH PLAY, TUMBLING, FLIPPING OR DIVING ALLOWED.
6. REMOVE SHOES, EYEGLASSES, AND ALL SHARP OBJECTS, INCLUDING JEWELRY.
7. NO FOOD, DRINK, GUM AND **ABSOLUTELY** NO SILLY STRING. (CLEANING CHARGE WILL BE ADDED)
8. NO WET FACE PAINT.
9. DO NOT OPERATE UNIT IN RAIN, LIGHTENING, DARKNESS, OR WINDS EXCEEDING 20 MPH.
10. IF THE UNIT BEGINS TO LOSE AIR, UNLOAD RIDERS. CHECK YOUR POWER SOURCE FOR A POSSIBLE POWER PROBLEM.
11. ONLY ONE RIDER IS TO GO DOWN THE SLIDE AT ONE TIME, FEET FIRST AND ON THEIR BOTTOM. NO RIDER CAN GO DOWN UNTIL THE RIDER BEFORE HIM HAS EXITED.
12. NO MORE THAN TWO PEOPLE AT THE TOP OF THE SLIDE AT ONE TIME.
13. RIDERS SHOULD NEVER ATTEMPT TO CLIMB UP THE SLIDE IN **THE WRONG DIRECTION.**
14. DO NOT ALLOW CHILDREN ON THE OUTSIDE TO KICK, HIT, JUMP OR CLIMB ON THE SLIDE.
15. MAXIMUM LOAD: 2 MAXIMUM WEIGHT: 250 LBS PER PERSON  
MINIMUM HEIGHT: 42" MAXIMUM HEIGHT: N/A
